

Observance of Vigilance Awareness Week – 2014.

CONCOR observed Vigilance Awareness Week from 27th October, 2014 to 1st November, 2014 at its Corporate Office, Regional Offices/ICDs/DCTs and CFSs. Vigilance Awareness Week was also observed at Fresh & Healthy Enterprises Ltd. (FHEL) and CONCOR Air, fully owned subsidiaries of CONCOR. The theme of the Vigilance Awareness Week this year was '**Combating Corruption – Technology as an Enabler**'.

Commencement of Vigilance Awareness Week with administering of Pledge:

The programme began at Corporate Office on 27.10.2014 at 10:00 hrs by taking pledge by all officers/staffs of all ranks. The pledge was administered by CMD in Corporate Office. Similarly, pledge was administered by the respective Head of the Office at all the Regional Offices/Container Terminals of CONCOR. CMD/CONCOR administered the pledge to the Board of Directors in the Board meeting held on 29.10.2014.

1. Debate Competition:

Employees from all over the country participated in Essay writing on “**Swatch Bharat Mission**” and slogan writing on “**Eradication of Corruption from Society**”.

Details of programmes undertaken by the Regions:

Eastern Region:

The observance of "Vigilance Awareness Week" at Eastern Region commenced with the pledge being taken by Officers / Supervisors & Staff across various Terminals of the Region. Department Heads and Sr. officers of ERO visited important Terminals for wide publicity to fight against corruption among the staff /officers, customers and stakeholders. A meeting with Business Associates/Customers was held on 29.10.2014 at Regional Office and on 01.11.2014 at CTKR (Kolkata) terminal.

South Central Region (SCR):

On 29th October, 2014 a meeting /interaction session conducted with stakeholder and business associates at ICD/SNF (Hyderabad) wherein ED/South Central Region was the Chief Guest. ED/SCR briefed the gathering about the vigilance aspects with greater emphasis on e-filing. It was also decided to give more thrust on e-filing as a tool to bring in greater transparency, customer empowerment and achieving greater customer satisfaction. Similar meeting was also conducted at DCT/Nagulapally on 30.10.2014 in which GGM(C&O)/SCR has participated as a Chief Guest and briefed about vigilance aspects. On 31.10.2014 similar programme was conducted at CFS-Vishakapatnam.
