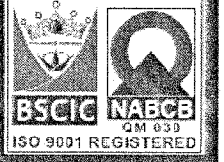

The similar nature of work would include orders in bidder's own name for supply and installation of hardware. Support	The bidder should be a total solution provider and should have either direct tie-up with the principals or their authorized dealers/partners for supply and providing necessary support.
