1. **SELLER:** Seller referred in these conditions of sale, is the Department of Customs, CSI Airport, Mumbai through the Custodian, Concor Air Limited (CAL)
2. **AUCTIONEER:** Ashvin & Co. is an agency appointed as an auctioneer to facilitate auction on Internet by the Custodian. They are expected to facilitate organising and conducting an auction and are considered as third party not particularly interested in the item being sold for and on behalf of CAL/Customs.
3. **BIDDER:** Any person representing as an individual OR as proprietor OR as a partner OR as an authorised representative of any company and who is paying the Earnest Money Deposit (EMD) and getting Registration with Auctioneer M/s Ashvin & Co. is considered as a registered bidder. One individual can represent as a bidder on his own behalf or on behalf of his company. But he cannot register separately for himself and company at the same time. Bidder must read the CAL Special Terms & Conditions (STC) and General Terms and Conditions (GTC) of the auction sale very carefully and then only place his signature on the Acceptance / Registration Form. By signing the Registration Form, the Bidder has agreed to accept and comply with the terms and conditions stipulated in the STC and GTC. 6. **Auction Goods:** All the consignments/Auction Goods will be sold on ‘LOT’ BASIS. The Auction Goods may be sold in one or more Lots as found suitable and convenient and/or advantageous in the opinion of CAL.
7. The Auction Goods are sold as they stand at the time of sale on “As Is Where Is Basis” And On “No Complaint Basis”, Quantities, qualities, sizes, measurements, numbers and weights whether announced verbally, at the time of Online Auction Sale or specified in the catalogue are sold on the assumption that the bidders have inspected the same and known what they are buying. The principle of Caveat emptor will apply. The Auctioneers/ CAL do not give any guarantee or warranty or undertake any responsibility for the make, manufacture, description, quantity, quality, condition, size, weight, grade, accuracy, soundness, completeness, etc., of the Auction Goods mentioned in the catalogue or verbally announced. The Lot(s) shall be removed in full from the site with all faults and flaws in description or otherwise and no selection or sorting of the material will be allowed. No complaint will be entertained after the Lot is SOLD.

PARTICIPATION

8. The prospective bidder has to register with the auctioneer Ashvin & Co. on payment of Registration charges Rs.1111 + 18% GST for one year at the office address mentioned hereinabove. The prospective bidder shall furnish all the necessary documents required for registration with Auctioneer to Ashvin & Co.
9. The prospective bidder has to pay LOT WISE Earnest Money Deposit (EMD) as mentioned in the Auction Sale LIST by way of Demand Draft/ Pay Order ONLY drawn on any Scheduled/ Nationalized Bank Drawn in the favour of “ Concor Air Limited ” payable at Mumbai. CASH WILL NOT BE ACCEPTED FOR EMD.

11. The RESERVE PRICE of a Sale Lot will be NOT be displayed on the bidding screen and shall be kept confidential by the Authority.
12. **EMD PAYMENT**
The Pre Bid Security Deposit /Earnest Money Deposit (EMD) shall be deposited with CALon or before 16th March 2018 by 4.00 pm.
13. **Refund of Pre-Bid Security Deposit / EMD:**
The Bidders who have not participated in bidding or Bidders who have not succeeded in the bidding can collect their DD/PO/BC from CAL/M/s. Ashvin & Co. on the next working day of auction.
Successful bidders shall be returned their DD/PO/BC upon making full bid payments including taxes.
The Pre-Bid Security Deposit / EMD may be adjusted against the bid amount payable, if the successful bidder so desires.
14. **Forfeiture of EMD:** In the event of the failure to make full payment of the Bid Amount within the specified time the sale relating to such Lot(s) of Auction Goods will be treated as cancelled and the Pre-Bid Security Deposit/EMD will be forfeited without prejudice to any other rights and remedies available to CAL.

STA AND BID AMOUNT PAYMENTS

15. The highest bid is declared on Subject to Approval (STA) basis. After the closure of the E-auction, the lots which are Provisionally Accepted by CAL and Customs on STA basis will be uploaded on the website and intimated to the successful/ highest bidder by Ashvin & Co.
16. On closure of the E-Auction thereafter the E-auction bids will be compared. On comparison of E-Auction bids whichever is highest and subject to the Reserve Price, the intimation of Provisional Acceptance to the E-Auction bidder will be sent ONLY through Emails recorded in the Registration Form and NOT by Courier/Post.
17. The highest/ successful bidder has to pay the Bid Amount along with taxes as applicable by way of Demand Draft/ Pay Order ONLY drawn on any Scheduled/ Nationalized Bank Drawn in favour of “Concor Air Limited” payable at Mumbai. Intimation will be sent to the Bidders regarding their bid being “Successful” / “Unsuccessful” and Bidders are expected to take efforts to find out status of confirmation of their bids. It is explicitly made clear that subsequent to the intimation, there should not be any excuse for non-payment and EMD will be forfeited if the highest/ successful Bidder /Buyer fails to pay the Bid Amount and other taxes before the due date.

LOT CONFIRMATION AND PAYMENT OF BID MONEY

18. All such lots which have been provisionally accepted on STA Basis shall be given a Final Confirmation or Rejection within 30 working days (excluding the date of the auction) by Ashvin & Co.
19. After intimation of the Final Confirmation the successful bidder shall as the “Buyer” of the Auction Goods has to deposit the Bid Amount along with taxes as applicable to CAL within Five (05) working days from the date of intimation of such Final Confirmation.
20. If the Buyer fails to make payment and/or take delivery of the material as per the stipulated timelines, CAL shall have the right to auction the undelivered material immediately in the next auction without any intimation to such Buyer and the EMD / bid money deposited by such Buyer shall be forfeited without prejudice to any other rights and remedies available to CAL.

TAXES and OTHER INCIDENTAL EXPENSES:

21. All bids invited are for the net amount accruable to CAL and relevant taxes, levies, etc. except Customs Duty, shall be payable by the Buyer to CAL and these taxes shall be treated as extra and not included in the Bid Amount and are expected to be paid to CAL before taking delivery.
22. If the delivery is not taken within the prescribed free time limit of 2 (Two) working days from the date of payment of full bid amount along with applicable taxes then demurrage will be charged as per prevailing public tariff at ACC. However, it must be noted by the bidders that it will be the sole discretion of CAL not to allow the Buyer to lift the goods with or without the demurrage charges after the expiry of the stipulated free delivery period.
23. Only after the Final Confirmation of Acceptance of Bid and payment of Bid Amount and all due taxes, the Tax Invoice and copy of Bill of Entry will be issued in the name of the Bidder/Buyer as is recorded in the Registration Form. Any further correspondence will only be with the Bidders on the name and address as recorded in the Registration Form. Kindly note, change in Bidder/Buyer Name shall not be entertained.

24. If the Buyer fails to make payment and/ or take delivery of the material, within the free period, or such extended period, CAL shall have the right to auction the undelivered material immediately in the next auction without any intimation to the Buyer and the EMD /bid money deposited by such Bidder shall be forfeited.

INSPECTION

25. Entry for inspection of goods on the date of display will be allowed to a person holding SALE LIST / CATALOGUE issued in his name by CAL. Goods are sold on “AS IS WHERE IS BASIS”, “NO COMPLAINT BASIS” and “All Goods will be sold on LOT BASIS”. CAL / Ashvin & Co. do not give warrantee or guarantee of the Quantity, Quality, Chemical composition of each individual item in the Lot or about the ‘End Use’ or fitness for a particular purpose.

ANNOUNCEMENTS

26. Announcements during the auction including announcement of any additional conditions OR correction in the catalogue and/ or additions or deletions of items being offered for sale are being done with the consent and knowledge of CAL and it is binding on the bidder.
27. Any Lot or part thereof may be withdrawn from the sale at any time before it is actually physically delivered out of the CAL facility/warehouse without disclosing the reason for such withdrawal. However, if any payment has been made it would be refunded.
28. In the event of any dispute with regard to non-lifting / non-availability of inspected materials etc. and forfeiture of EMD/ Bid Amount, CAL /Ashvin & Co. will not be held responsible for such loss / forfeiture.

DELIVERY

29. If the Buyer fails to take the delivery of the goods within 5 (Five) days, or such extended period, from the date of intimation of Final Confirmation of bid, the EMD / Bid Amount deposited by him will be forfeited and the cargo will be relisted for sale at his risk and cost.
30. No sale shall be invalidated by reason of any defect or fault in any of the Auction Goods or Lots or by reason of any error or fault in the description thereof in the catalogue of particulars and no compensation shall be paid in respect of any such defect or fault or error or mis-description.
31. The Auction Goods shall lie at the sole risk and responsibility of the Bidder/Buyer in all respects from the time of sale and must be taken away by the Buyer at his own expense.
32. Delivery will be given only during the office hours on working days of CAL
33. The Buyer shall produce the receipt of Full and Final Payment paid to CAL along with GST and other taxes for proper identification of the Bidder at the time of taking delivery of the material.
34. Should the original Bidder/Buyer wish to take the delivery of the goods through a CHA or his representative, he must authorize this representative through a letter of authority with ID proof, which shall be presented to CAL. Delivery by proxy will be at the Bidders sole risk and responsibility and no claim shall lie against CAL on any account whatsoever, if the delivery is affected to the wrong person(s).
35. While taking delivery of the material, it will be at the discretion of the authorized representative of CAL to direct the manner / order in which the materials or Lots shall be removed. No segregation of the items of any Lot is allowed inside the CAL premises.
36. In case the whole or any part of the Auction Goods sold remain uncleared, even after the authorized period stated in the delivery schedule, the Buyer shall have no claim whatsoever on the goods remaining uncleared and the amount paid for bidding will stand forfeited at the expiry of the said period. CAL shall have the right to dispose of such goods in any manner it likes. The Bidder/Buyer will have no right whatsoever to any compensation in such circumstances.
37. Such charges as shall accrue from the date of expiry of the period as specified until the Lot is completely removed shall be recovered from such Buyer before the Sold Goods are allowed to be removed. Should the Buyer fail to take the delivery within the time mentioned or to pay the demurrage as the case may be, the purchase price along with applicable Taxes, if any, paid by him shall stand forfeited, without any prejudice to CAL who further reserve the right to recover damages on account of such breach from such Buyer to whom the Lot was originally SOLD.

38. In case, if CAL could not deliver the goods within the specified time due to unanticipated administrative reasons, then suitable extension of period shall be granted to the Buyer and he will not be liable to pay any demurrage till the expiry of such extended period. In such eventuality, however, such Buyer cannot claim any compensation for such delay.
39. Goods are sold in Lot Basis and not by number or units, in the event of the lot or lots being found to be deficient in quality, quantity, sizes, measurement, number or weight as stated in the catalogues, the Buyer shall have no claim on CAL/ Ashvin & Co. for refund of the whole or any part of the purchase money or for loss or profit or interest or any other damages.
40. The delivery of the material either in part or in full would be subject to being withheld if required by CAL /Customs at any stage before the actual delivery without any commitment on either side.
41. CAL / Ashvin & Co. shall not be responsible for any loss or liabilities of the bidders if the purchased lots could not be delivered due to circumstances beyond the control of CAL.
42. Resale will not be recognized and the delivery orders will be issued in the name of the actual/ original bidder only. If the Auction Goods are found to be other than described in this catalogue, CAL reserves the right to refuse to deliver such Auction Goods and reject the bid at any stage. Any amount paid in part or full shall be refunded without any interest.
43. No interest shall be paid on EMD or any money deposited in case the material is not delivered for any reason. All prospective bidders/Bidders shall be deemed to have read and understood these conditions of sale, listed herein and be bound by these terms and conditions and to give their bids subject to these conditions.

EXCLUSIVE RIGHTS

44. CAL reserves the right to modify and amend the terms and conditions in this catalogue and announce or publish on website, any modified terms and conditions, if need be, while the auction is in progress or prior to commencement of auction.

GENERAL

45. Employees of CAL / Ashvin & Co. are barred from participating in the Online Auction.
46. Any Lot will be put for auction as per convenience of CAL. It is not obligatory for CAL to auction the items as per the serial number.
47. Bidder and his men are subject to the security rules and regulations of CAL/MIAL in force while in the Airport / MIAL premises. The Bidder, workmen, agents or representatives shall not commit any nuisance, theft or indulge in any antisocial activities in the premises and the Bidder shall be liable for the good conduct, safety and discipline of his workmen. In case of any such activity, delivery will be suspended and strict action as per law will be taken including forfeiture of EMD.
48. The Bidders/Buyers shall be responsible for any damage that may be done to premises/ fittings of CAL in the course of removing the lot or lots purchased by them. The authority may at its option arrange to make good such damages and the bidder/Buyer shall pay for the same on demand.
49. During the period the bidders/Buyers workers are engaged within the CAL premises they will be governed by the labour laws and rules, Factory Acts and Rules and CAL Safety/ Security Rules as applicable. It shall be the responsibility of the bidder/Buyer to see that the statutory provisions are complied with.
50. In the event of failure on the part of the successful bidder/Buyer to fulfill his contractual obligations, CAL / Ashvin & Co. reserves the right to debar such bidder from participating in any future tender/ auction conducted on behalf of CAL
51. If any Court Case comes up after the sale of auction of the Specific Lot, the EMD/Full payment shall not be refunded till the time court verdict/Customs Order is given by the competent authority. No interest for that period shall be paid to any of the parties.

ARBITRATION

52. In case of any dispute, the same shall be referred to a single arbitrator, to be appointed by the **Concor Air Ltd.** and the Arbitration proceedings would be governed by 'Arbitration and Conciliation Act' 1996. The fees and expenses towards arbitration proceedings shall be shared, equally, by the parties to the dispute and shall be paid in advance to arbitrator. The jurisdiction for appealing against the award in a court, or any other proceedings under the Arbitration Act, shall be that of courts in Mumbai city only.
53. CAL will not be in any way responsible for failure to deliver the goods as per delivery schedule due to causes beyond their control such as strikes, lockouts, cessation of labour, shortened hours, acts of God or other causes or contingency whatsoever. The bidder/Buyer shall not be entitled to cancel the contract and the period of delivery shall automatically be extended accordingly.

ACCIDENTS ETC. TO THE BIDDER / LABOUR

54. CAL/MIAL/ Ashvin & Co. will not at any time be responsible for any injuries caused due to accident within CAL/MIAL premises or at the place of work of the owner either to the bidder/Buyer or his representative/ labour etc., and the bidder/Buyer will make proper arrangements for any claim arising out of the employment under any statute. It is the responsibility of the bidder/Buyer to provide necessary safety appliances (like hand gloves/ safety shoes etc.) to his labourers, who are engaged for loading/ unloading of the materials.
55. CAL / Ashvin & Co. will not be liable for any claim and Bidder shall keep CAL / Ashvin & Co. fully indemnified and harmless against any claim and proceedings of any of their own or against the employees or others.
56. No gas cutting equipments or any equipment which are likely to cause damage will be allowed in the CAL premises.

CONDITIONS APPLICABLE TO ONLINE AUCTION METHOD OF BIDDING
