Online (Transportation of containers between DCT-Sabarmati and Other destinations) only through e-tender cum reverse auction mode (in two bid mode).

For reverse Auction intimation would be sent by CONCOR to bidders in advance and bidders need not to come to CONCOR office for e-Reverse Auction.

2. In case number of technically qualified bidders are three or more the e-reverse auction will be conducted. In case the number of technically qualified bidders is upto two, it will be proceeded through normal e-Tendering mode.

3. The lowest total price quoted by technically qualified bidders in the financial bid, will be the opening price for e-reverse auction.

EMD to be paid through e-payment and the receipt of the same should be scanned and uploaded in the e-tendering website www.tenderwizard.com/CCIL.

To participate in the E-Bid submission, it is mandatory for the bidders to have user ID & password which has to be obtained by submitting an annual registration charges of INR **1500/- + GST @18%** to M/s. ITI through e-payment. Bidders have to pay the Tender Processing Fee to ITI through e-payment at the time of submission of bid.
