13. Bidders submitting their offers as MSEs registered for the item tendered shall be exempted from the tender fee only if they submit the current and valid registration certificate.
14. MSEs registered with designated agencies shall be exempted from payment of sale price of tender document on submission of copy of valid registration for the tendered item.
15. Bidders quoting as MSEs for the tendered item shall be exempted from the payment of Earnest Money Deposit (EMD).

Bids not accompanied by a valid registration certificate shall be treated as bids from Non-MSEs.
18. The bidders qualifying as MSE (who submit copy of valid registration certificate as per Clause above) shall be given the following exemptions: -
  - (i) Tender sets shall be issued free of cost to MSE's registered with the above agencies for the item tendered on submission of registration certificate.
  - (ii) MSE's registered with the above agencies for the item tendered will be exempted from payment of Earnest Money Deposit (EMD).
19. MSEs should submit the copy of valid MSE certificate in the bid. In the event of non-submission of the above, the bid shall be summarily rejected
20. Eligible MSE(s) quoting a price within price band of L1+15% shall be allowed to supply a portion of the requirement by bringing down their price to L1 price in a situation where L-1 price is from someone other than a MSE and such MSE's can be together ordered up to 20% of the total tendered value.
