Online open tender in two bid system is invited for Supply, Installation & Commissioning of Hardware (PCs, Printers, MFPs, Router, Switches & UPS) and Software (MS-Office) at ICD-Mulund (Mumbai), Dronagiri (Navi Mumbai), MMLP Tihi (Indore) and MMLP Balli (Goa) for EDI Customs, only through e-tendering mode.

Experience with respect to similar nature works	The minimum amount of single work of the similar nature should be amounting to ₹ 27,92,024/- <u>or</u> multiple works of similar nature amounting to ₹ 41,88,036/- completed during previous 36 months prior to the date of tender opening. The similar nature of work can include order for supply of All-In-One Desktop/PCs, Printers, MFPs, Routers, Switches and Order for support (AMC's) of these items. Out of these orders, at least one order should be of supply of All-in-One Desktop/PCs and proof of completion of such projects is to be submitted by the bidder. The above mentioned details should be supported by copy of Purchase orders along with the completion certificate.
Support	The bidder should be a total solution provider and should have either direct tie-up with the principals/OEMs or their authorized dealers/ partners for supply and providing necessary Warranty/AMC support. The bidder should submit authorization certificate/ documentary proof of such tie-ups along with the technical bid.

1. Tender Document/sets shall be provided free of cost to Micro & Small enterprises (MSE's) registered with the listed agencies.
