Online Open Tender in Two Bid System for Implementation of Dual MPLS connectivity for CONCOR's Central site, Backup Site & All India Remote locations, Associated Network & Security Devices, On-site Support (24\*7 basis) at Central Site and Managed Services for Links on turnkey basis for a period of Three Years **only through e-tendering mode.**

Minimum annual turnover	The average annual turnover of the bidder during the last three financial years should not be less than ₹ 1,18,14,95,953.00 (Rupees One Hundred Eighteen Crore Fourteen Lac Ninety Five Thousand Nine Hundred and Fifty Three Only). The information shall be supported by the copy of Chartered Accountant's certificate.  In case of consortium*, the average annual turnover shall be determined by adding together the average annual turnover of all the partners. However, the lead partner must have at least 60% of the minimum average annual turnover mentioned above.
Experience with respect to similar nature works	The minimum amount of single work of the similar nature should be amounting to ₹ 58,26,55,538.00 or works of similar nature amounting to ₹ 87,39,83,308.00 during previous 84 months (7 years) prior to the date of tender opening. The bidder should also submit authorization certificate from the VPN/ MPLS/ Wireless service providers authorizing them to bid for this tender/ requirement for CONCOR along with the technical bid.</p> <p>The bidder/ OEM/ Consortium Partner/ ISPs should have either support office or engineer stationed in the same city as that of CONCOR location to provide necessary support for the devices &amp; links. Details of support offices/ engineers may be submitted.</p> <p>The similar nature of work shall include order for Supply, Support (AMC) for Network &amp; Security Devices, Onsite Support, Implementation &amp; Maintenance of VPN/MPLS either in single order or separate orders.</p> <p>The bidder should have experience of implementation of IT hardware/ network and running and managing at least one network of VPN/MPLS/Wireless of at least 55 locations with a Central Site during last 7 years. Proof of such projects/ orders in the name of bidder's own company/ subsidiary company/ parent company/ Consortium partner either executed or running successfully is to be submitted by the bidder.</p> <p>The above mentioned details should be supported by copies of Purchase orders alongwith the completion certificate indicating completion of such activities i.e. supply/ implementation/ integration/ migration/ support /on-going services (separate orders or combined orders). Value of each completed year would be considered for the above requirement.</p> <p>The experience of the consortium partner shall also be considered; however, the lead partner must have at least 60% of the works executed in terms of value.</p>
Authorization	<p>The bidder should be a total solution provider and should have either direct tie-up with principals/ OEMs/ ISPs for providing necessary support or through their authorized dealers/ partners.</p> <p>The bidder should submit authorization certificate from the principals/ OEMs/ respective ISPs authorizing them to bid for this tender/ requirement for CONCOR along with the technical bid.</p> <p>The Unified Licenses/ NLD/ ISP or similar for providing MPLS/VPN should be valid at the time of submission of the bid and should be renewable in order to cover the entire period of contract. Copy of the such documents/ license should be submitted.</p>
Support	<p>The bidder/ consortium partner should have experience of supporting IT Hardware/ Network/ Security and Managing &amp; Running at least one network of VPN/ MPLS/ Wireless Telcom in Datacenter connected with at least 55 remote locations on intranet on 24x7 basis at least for one year. Proof of such projects completed or running (complete years) is to be submitted by the bidder.</p>

**\*Constitution of Consortium:**

One of the members of the Consortium shall be the lead member who shall have an at least 60% share of interest in it. Other members of Consortium shall have at least 15% (fifteen per cent) stake each.
